Nepal November

Por two weeks in October and November, Ken Yates was in Nepal. He taught a class to pastors and other church workers there on 1 and 2 Corinthians. The students could all speak English and had many questions, especially as they related to Free Grace issues and the Judgment Seat of Christ.

The majority of people in Nepal are Hindu and these students were all first generation Christians.

Ken was also able to give the students information on how to locate and use Free Grace material on GES's website.

In addition, on October 30, he was asked to preach at a

church outside of Kathmandu. The church was damaged in the massive earthquake that hit in April of this year.

Over 9000 people were killed. The church replaced the damaged structure with a tin building. About 50 people attended the service, and the people sat on pillows on the ground. Ken did not know the spiritual condition of the people so he spoke about the freeness of the gospel and the assurance that comes with it from various passages in the Gospels. Ken had a translator as the people did not speak English. The message was very well received and the congregation wanted Ken to return on another visit to their country.
